As the ski season is upon us, this memorandum is to clarify what role Creekside Charter Management plays in our students participating in skiing and other winter sport activities. I understand that many of our students receive ski lessons and training both during and after the hours that the School provides educational programs at 1916 Chamonix Place, Olympic Valley CA (close proximity to Squaw Valley). Further, an objective behind Creekside offering independent study is so that our students can foster outside passions and interests. However, please be aware that Creekside Charter Management does not offer and is not affiliated with any skiing or other winter sport program. Accordingly, you are solely responsible for determining whether any particular ski or winter sport program fits your student's needs and offers services in a safe manner. You are also solely responsible for transportation to and from the sport activities and the School, this includes a parent's right to allow a student to sign themselves out of school.

If a student will be leaving our resource centers prior to the regularly scheduled departure time to receive ski lessons and training, Creekside Charter Management will need for you to complete the attached acknowledgement form and return it to me. Students who do not have the attached form on file will not be released prior to the scheduled departure time without a parent picking them up on campus.

- I understand that Creekside will not undertake the supervision of the Student once he/she has left the Creekside Resource Center.
- The Student's involvement in extracurricular athletics involves potential risks, including but not limited to the Student suffering serious personal injury (including death), and I (on behalf of the Student if the Student is under eighteen (18) years of age) hereby expressly assume any, and all risks, known or unknown, anticipated or unanticipated, associated with the Student's participation in extracurricular athletic activities.
- Pursuant to Education Code Section 35330, I (on behalf of the Student if the Student is under eighteen (18) years of age) release, hold harmless, and will indemnify Creekside Charter Management, its officers, employees, agents and volunteers from any and all actions, liability, damages or expenses arising from or in any way related to the Student's participation in extracurricular athletic activities and transportation to and from these activities.
